Secretary Report

Emily Thompson read the minutes of the July board meeting. Minutes approved.

Report on memberships numbers: currently have 29 teachers and 2 parent members. Forms submitted do not include Diana Hummel, additional ISA teachers. Will follow up and add these people before deadline end of October.

All member teachers must be current members of SAA. Suggestion that we continue to reach out to more teachers in the SAA directory.

The University of Evansville Suzuki Violin program will have a picnic on October 21 with a birthday cake for Dr. Suzuki, inviting all the teachers and students in the program. We should encourage other teachers to have a token event and/or mention Dr Suzuki's birthday in their studio. It's important to talk about Dr. Suzuki and keep his memory going.

For the next annual meeting, we need to decide on the afternoon feature. This past year (2017) we had a member discussion and could have easily gone longer than the time we had.

- Have Ann Sloan talk about the IAM Fest
- Have Austin Huntington (principal cello of the Indianapolis Symphony) come and talk about his experience as a Suzuki student. [He was a student of Emilie Grondin; Emilie will ask him about it.]

Other Events

We would like to have an SAI hosted workshop during the year. We need to have a teacher workshop to draw in new teacher members.

The main suggestion was for Ed Sprunger to come as the workshop teacher. Ann Sloan knows him and will ask him about:

- his availability
- how much it will cost to bring him here
- charge for participants (we can charge more for non-members as an incentive to join the SAI)

We can send Liz our individual ideas about possible details of the workshop.

Emily Thompson suggested that if Sprunger is not available, we could follow through the workshop idea and ask someone else. Discussion continued:

- We need to have someone with substantial appeal to our members
- We need to clarify what we want the teacher to do: talk to parents and teachers vs. teaching students [Ann]
- It would be helpful to have a teachers and parents practicing workshop. [Liz]

Liz concluded by affirming our goals to acknowledge the amazing teachers in our midst and share ideas to help build up all of our members.

Emily Thompson moved to adjourn the meeting, and the motion was approved unanimously.
